22 1. I am an attorney at law, duly admitted and licensed to practice before the

26 testify hereto.


27 2. On April 25, 2014, at approximately 9:00 a.m., I advised cross-defendant

1 Summer Reese by telephone voice mail and email that our firm would be appearing ex  
2 parte at 9:00 a.m. on Monday, April 28, 2014 in Dept. 15 for a temporary restraining  
3 order restraining cross-defendant Summer Reese, and those acting in concert with her,  
4 from entering, remaining, blocking or impeding ingress into or egress from, or the  
5 passage of persons through, Pacifica Foundation Radio facilities, including, but not  
6 limited to the Pacifica Foundation Radio's National Office. I further advise her that we  
7 will also be applying for an order to show cause why a preliminary injunction should  
8 not be granted enjoining cross-defendants from committing the above-described acts  
9 during the pendency of this action. I similarly advised plaintiff's attorney, Amy  
10 Sommer Anderson, of the above, by telephone voice mail and email, at 9:00 a.m. on  
11 April 25, 2014.

12 3. At the time of this declaration, I did not receive any response from Ms.  
13 Reese or Ms. Anderson.
